Amendment No. 6 to Schedule 13D

This Amendment No. 6 (this "Amendment") amends the Schedule 13D filed by Photon Group Limited, a British Virgin Islands corporation ("Photon"), with the Securities and Exchange Commission (the "SEC") on June 16, 2004, as amended by Amendment No. 1 filed with the SEC on April 1, 2010 ("Amendment No. 1"), by Amendment No. 2 filed with the SEC on July 8, 2011 ("Amendment No. 2"), by Amendment No. 3 filed with the SEC on April 10, 2017, by Amendment No. 4 filed with the SEC on June 8, 2018 ("Amendment No. 4"), and by Amendment No. 5 filed with the SEC on September 21, 2018 ("Amendment No. 5"). The original Schedule 13D of Photon, as amended by Amendment No. 1, Amendment No. 2, Amendment No. 3, Amendment No. 4, and Amendment No. 5, is hereinafter referred to as the "Initial Statement."

Item 3. Source and Amount of Funds or Other Consideration.

The following are transactions by Photon in ordinary shares, par value \$0.001 per share ("Ordinary Shares"), of Sohu.com Limited, a Cayman Islands company (the "Issuer"), that have occurred since the filing of the Initial Statement:
